**PARTIAL SUMMER OFFER**

Dear CCRA Waiting List Member:

The Chevy Chase Recreation Association is pleased to offer you Partial Summer use of CCRA for the 2017 Season. Privileges include daily use of swimming and tennis facilities beginning Monday, July 24<sup>th</sup> until closing in Mid-September (includes the Tennis reservation service beginning Monday, July 24, 2017). Children are **not** eligible for the swim team with the Partial Summer use.

Dues are \$475.00, postmarked by April 10, 2017. If the dues are postmarked after April 10<sup>th</sup>, the amount increases to \$515.00. After April 24<sup>th</sup>, the fee increases to \$530; however, your Partial Summer rights cannot be guaranteed after April 24, 2017.

Active Tennis Players, please include a fee of \$40, \$80, \$120 or more depending on your frequency of playing with guests. \$40 Tennis guest cards (5 Adult guests @ \$8 each) will be credited to your account and placed in your pool file. More may be purchased during the summer.

You and your family may participate in tennis programs prior to your start date if there is room in the program. The Tennis Director, Betsy Heidenberger, has programs beginning April 17<sup>th</sup>. Pool Guest cards are \$40 (Children \$5 daily & Adults \$8 daily). Houseguest passes (7 consecutive day visitor pass) are \$25 for adults & \$15 for children. These may be purchased now or later at the pool desk. An \$85 Caregiver Pass should be pre-purchased for your Nanny, Au pair or Caregiver. Please include their name and birthdate on your signature card. You may sign up for swim lessons beginning July 24<sup>th</sup>.
