COMBINATION USE - WEEKDAY + PARTIAL SUMMER OFFER

Dear CCRA Waiting List Member:

The Chevy Chase Recreation Association is pleased to offer you a Combination of Weekday and Partial Summer use of CCRA for the 2018 Season. **Your first day of use is Tuesday, May 29, 2018.** Weekday use is for the swimming facilities and “unreserved” tennis courts through July 20, **not including** Holiday weekdays; and, full everyday use of swimming and tennis facilities from Monday, July 23rd until closing in Mid to end of September (September 16 or 30 - TBD).

Dues are \$750.00, postmarked by April 13, 2018. If the dues are postmarked after April 13th, the amount increases to \$790.00. After April 27th, your Combination rights will increase to \$815; however, your Combination rights can no longer be guaranteed. Please call to confirm availability.

Tennis reservation service is available for your use beginning Monday, July 23rd. **Weekend use begins Saturday, July 28th.** Active Tennis Players, please include a fee of \$40, \$80, \$120 or more depending on your frequency of playing with guests. \$40 Tennis guest cards (5 Adult guests @ \$8 each) will be credited to your account and placed in your pool file. More may be purchased during summer by check only. Many tennis programs begin on April 14th. Click here for the schedule.

Pool Guest cards are \$40 (Children \$5 daily & Adults \$8 daily). Houseguest passes (7 consecutive day visitor pass) are \$25 for adults & \$15 for children. These may be purchased now or later at the pool desk by check only. A \$155 Caregiver Pass should be pre-purchased for your Nanny, Au pair or Caregiver. Please include their name and birthdate on your signature card.
