FULL SUMMER RIGHTS OFFER

Dear CCRA Waiting List Family:

The Chevy Chase Recreation Association is pleased to offer you **Full Summer** use of CCRA for the 2018 Season. Privileges include full use of swimming and tennis facilities for the 2018 Season. Dues are \$900.00, postmarked by April 13th. If the dues are postmarked after April 13th, the amount increases to \$940.00. After April 27th, the rate for Full Summer rights increases to \$965, but can no longer be guaranteed; therefore, please contact Sue Kamenar to confirm availability.

Active Tennis Players, please include a fee of \$40, \$80, \$120 or more depending on your frequency of playing with guests. \$40 Tennis guest cards (5 Adult guests @ \$8 each) will be credited to your account and placed in your pool file. More may be purchased during the summer.

For information about swim team, please go to www.ccrastingrays.com or email: Stingraysareps@gmail.com. For those interested in swim lessons, they cannot be scheduled until the week after we open on Memorial Day Weekend, Saturday, May 26th. Lifeguards are normally not available to provide these lessons until at least a week after opening.

Pool Guest cards are \$40 (Children \$5 daily & Adults \$8 daily). Houseguest passes (7 consecutive day visitor pass for visitors in your home) are \$25 for adults & \$15 for children. These may be purchased now or later at the pool desk. A \$155 Caregiver Pass should be pre-purchased for your Nanny, Au pair or Caregiver. Please include their name and birthdate on your signature card.

FYI, within the next year or two, you should receive a Permanent Membership offer. At that time you are responsible for two nonrefundable fees: a one-time \$1,500 initiation fee plus a \$1,100 one-time capital assessment fee. Annual dues for permanent members (\$600) are billed in February of each year, via postal mail. All fees subject to change in future years. If you do not accept a Permanent membership, you may **not** apply and start over at the bottom of the waiting list.
