NEW FOR THIS YEAR: LOOK FOR AN EMAIL WITH INSTRUCTIONS FOR CREDIT CARD OR ACH PAYMENTS. SIGNATURE CARDS ARE REQUIRED TO BE FILLED IN & RETURNED EACH YEAR.

This is the only Annual Dues Notice you will receive. Tennis Players, please include fee of \$40 per Tennis guest card (\$8 each guest). Swim Families, please purchase \$40 swim guest cards (adult @ \$8 each day & children @ \$5 each day). Visiting Houseguests are \$25 each per consecutive seven-days. Nanny pass is \$155 for the summer season.

\$260.00 --- EMERITUS PRIVILEGES FOR SENIORS (12 visits) -- Postmarked March 1 – March 15, 2019

PLEASE ADD AN ADDITIONAL \$25 PENALTY IF POSTMARKED AFTER MARCH 15, 2019. THANK YOU.

IN ACCORDANCE WITH CCRA BY-LAWS, ARTICLE VI, SECTION 5, A MEMBER MAY NOT BE IN AN **INACTIVE STATUS** FOR MORE THAN THREE CONSECUTIVE YEARS. If the following space is checked _____, you have been in an inactive status for three consecutive years and must pay Active dues, resign and simultaneously take Emeritus status or decide that it is time to resign completely. If totally resigning, you will certainly be missed!

Emeritus status is for long standing CCRA Permanent members who are senior citizens, at least age 65, in a one or two-adult household, who wish less frequent use. The total of years of permanent membership and age of the member must total 90. For example, a 70-year-old permanent member needs to have been a permanent member for at least 20 years, etc. Each of the members must be at least 65 years of age. You must resign your permanent membership. For pre-1988 memberships, accepting Emeritus status will mean no membership can convey with the sale of your home. If interested, please see full Emeritus description on the member website or ask business office to send a copy of the full description.

Each Emeritus member and spouse will receive twelve uses each season. If one member uses all 12 visits, but the other does not, the two members must come together and the member without any uses left must pay guest fees as a guest of husband or wife in attendance. You may also purchase guest cards and bring guests with you.
