Dear CCRA Waiting List Member:

The Chevy Chase Recreation Association is pleased to offer you Weekday use of CCRA for the 2019 Season. **Your first day of use is Tuesday, May 28, 2019.** Privileges are limited to the swimming facilities and vacant, unreserved tennis courts on weekdays only. Your limited use does **not** include the first two Summer Holidays (Memorial Day and Fourth of July). Children qualify for Swim Team participation.

Dues are \$585.00, postmarked by April 19, 2019. If the dues are postmarked after April 19, the amount increases to \$625.00. After April 30, the fee increases to \$650; however, your Weekday rights cannot be guaranteed after April 30, 2019; therefore please contact me to verify availability.

Pool Guest cards are \$40 (Children \$5 daily & Adults \$8 daily). Houseguest passes (7 consecutive day visitor pass) are \$25 for adults & \$15 for children. These may be purchased now or later at the pool desk by check only. A \$155 Caregiver Pass should be pre-purchased for your Nanny, Au pair or Caregiver. Please include their name and birthdate on your signature card.

Tennis reservation service is not available with the Weekday use; however, you may walk on to play if courts are open. Active Weekday tennis players, please include a fee of \$40, \$80, \$120 or more depending on your frequency of playing with guests. \$40 Tennis guest cards (5 Adult guests @ \$8 each) will be credited to your account and placed in your pool file. More may be purchased during summer. For information about Adult and Junior tennis programs, clinics, individual lessons and leagues, please go to the website page by clicking here. Many programs begin in April.
